# ANNUAL GENERAL MEETING TO BE HELD ON 18 MAY 2020

- Manulife US Real Estate Management Pte. Ltd., as manager of Manulife US Real Estate Investment Trust ("Manulife US REIT", and as manager of Manulife US REIT, the "Manager"), refers to:
  - (a) its announcement of 7 April 2020 on the obtaining of the SGX's approval for the time extension to hold its annual general meeting ("AGM") by 30 Jun 2020;
  - (b) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, inter alia, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means; and
  - (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, inter alia, general meetings of companies.

 Date, time and conduct of AGM. The Manager is pleased to announce that pursuant to the Order, its AGM will be convened and held by way of electronic means, on Monday, 18 May 2020 at 10.00 a.m. (Singapore time).

The Manager's Chairman, Mr Hsieh Tsun-Yan and Chief Executive Officer, Ms Jill Smith will conduct the proceedings of the AGM and address substantial and relevant questions which unitholders have submitted in advance.

- Notice of AGM and proxy form. The Notice of AGM and proxy form will be sent to unitholders solely by electronic means via publication on Manulife US REIT's website and will also be made available on the SGX website<sup>1</sup>. Printed copies of these documents will <u>not</u> be sent to unitholders.
- 4. No personal attendance at AGM. Due to the current Covid-19 restriction orders in Singapore, unitholders will not be able to attend the AGM in person.
- 5. Alternative arrangements for participation at the AGM. Unitholders may participate at the AGM by:
  - (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
  - (b) submitting questions in advance of the AGM; and
  - (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.
