



## **MANULIFE US REAL ESTATE INVESTMENT TRUST**

### **PAYMENT OF FY2019 PERFORMANCE COMPONENT OF MANAGEMENT FEE BY WAY OF ISSUE OF UNITS IN MANULIFE US REAL ESTATE INVESTMENT TRUST ("MANULIFE US REIT")**

Manulife US Real Estate Management Pte. Ltd., as manager of Manulife US Real Estate Investment Trust (the "**Manager**"), wishes to announce that a total of 1,353,016 Units in Manulife US REIT ("**Management Fee Units**") have been issued on 28 May 2020 at an issue price of US\$1.0055 per Unit to Manufacturers Life Reinsurance Limited ("**MLRL**"), an entity nominated by the Manager to receive the Management Fee Units in its place<sup>1</sup>.

The Management Fee Units have been issued as payment of 100% of the Manager's performance fee ("**Performance Fee**") for the financial year ended 31 December 2019 ("**FY2019**").

The Performance Fee is calculated in accordance with the trust deed constituting Manulife US REIT dated 27 March 2015 (as amended and restated) (the "**Trust Deed**"). In accordance with the Trust Deed, the Manager may elect to receive the Performance Fee in the form of cash and/or Units, in such proportion as may be determined by the Manager. The Manager has elected to receive 100% of the Performance Fee for FY2019 in the form of Units.

The issue price of the Management Fee Units is based on the volume weighted average price for a Unit for all trades on Singapore Exchange Securities Trading Limited (the "**SGX-ST**") in the ordinary course of trading on the SGX-ST for the last 10 business days immediately preceding (and for the avoidance of doubt, including) 31 December 2019. Following this issuance, the Manager holds 3,865,143 Units. The total number of Units in issue as at 28 May 2020 is 1,573,459,089.

<sup>1</sup> The Manager has sold the Management Fee Units which it is entitled to receive as payment of the Performance Fee to MLRL, a wholly-owned subsidiary of The Manufacturers Life Insurance Company, and in connection with the sale, the Manager has directed that such Management Fee Units be issued directly to MLRL instead of the Manager.
